





that the survey essentially relied on just 12 people. The results would =
be substantially different if only one of the 12 were biased in one way =
or the other. The paper does not report any test for rater bias, an =
astonishing oversight by authors and referees. If rater IDs are =
released, these tests can be done.=20

> Because so few took the survey, these few answered on average more =
than 4,000 questions. The paper is silent on the average time taken to =
answer these questions and, more importantly, on the minimum time. =
Experience has that interviewees find it difficult to stay focused if a =
questionnaire is overly long. The questionnaire used in this paper may =
have set a record for length, yet neither the authors nor the referees =
thought it worthwhile to test for rater fatigue. If time stamps are =
released, these tests can be done.=20
> Could you therefore kindly remind the editor that scrutiny of results/
is a key part of science? It would be best to release all data to =
anybody. The authors' concerns about confidentiality strike me as bogus/
However, if these concerns stand up, data could be released under a =
confidentiality agreement. The third-best alternative would be to tell =
the authors to perform the appropriate statistical tests themselves and
report the results.=20
